### **1. Eligibility Criteria**

i) Qualification:

- Essential Qualification: The minimum qualification is that of a Post Graduate Degree in any subject from a University Grants Commission Recognised University on full time basis.
- Desirable: Any one of the professional qualifications such as CA/CS/ICWA/MBA/MCA

ii) Experience

## **2 . Remuneration:**
